# ANNUAL MEETING

The 2010 Homeowner's Association meeting was held in November at HJ MacDonald School. Many ideas were discussed and the minutes have been posted to the HOA website.



There was talk of a Spring meeting to discuss the future of the HOA; however, this will not take place at this time. The issue will be revisited at the yearly meeting in November.

The Secretary and 1 and 2 Year trustee were reelected for another year while the President and Treasurer were reelected on a temporary basis until replacements are found. We need additional volunteers to take positions or a management company will need to be hired which will cause the yearly rates to increase. The yearly dues were kept at \$60 for 2011; however may be raised in 2012 as allowed in the by laws.

### ANIMAL CONTROL

The City of New Bern has multiple rules concerning pets. All pets are required to be leashed when not on your own property. Cats are included in this law along with dogs. The animal control laws state that dogs can not be a nuisance by barking, yelping or howling as to disturb the neighborhood. The city also requires that all animals must be vaccinated against rabies. The laws allow for the city to impound any pet which is found to be in violation.

Remember to have identification on your pet in case they do get loose so that they can be returned home to you.

Please contact the Animal Control Department of the New Bern police at 252-633-2020 when you see animals out on the streets to control this problem.

# BE A GOOD NEIGHBOR
